### Community Advocacy: Stories of Successful Policy Change 'From the Bottom Up'

This year's opening general session will feature two examples of local policy development that have led to broad improvements in public health. In an effort to combat high rates of diabetes and other chronic diseases on the Diné (Navajo) reservation, the tribal government passed the *Healthy Diné Nation Act of 2014*. The law imposes a tax on junk food such as candy bars and sodas by 7 percent and eliminates the tax on healthy foods like fruits and vegetables. Two community health activists at the forefront of this effort, Denisa Livingston and Danny Simpson, will share their unique journey and how it can be used to help other communities. Juan Reynosa, from the Southwest Organizing Project will present examples and offer insights regarding the unique challenges of achieving environmental justice locally and how difficult it is to empower communities when facing big corporations. #### Effective Advocacy: From Grassroots to the Roundhouse

Social transformation through effective advocacy for health policy during any particular time period often brings out the best and worst in political actors and ensuing legislation. Likewise, many reactionary forces have targeted and implemented oppressive upstream policies to remove needed basic and advanced public health services by favoring the wants of the 1%, the superrich who unduly influence legislation and higher education. Key factors for successfully building communities of practice at multiple levels within public health actions and social justice require a revitalized leadership framework for implementing health-in-all policy (HiAP)

approaches. We can increase the values in solidarity for population health through innovative approaches in health literacy and community education. Public leadership for a more open participatory democracy supports advocacy for transformational stewardship and solidarity in HiAP. Overall, community readiness and public leadership that transforms organizations in the  $21^{\rm st}$  century will have successfully promoted capacity building for social justice.

In this breakout session, Deswood Tome will present an historical look at Native American Tribes, injustices, U.S.-Indian policy periods, and how policy shapes lawmaking in Indian

#### **SECOND BREAKOUT SESSIONS**

A: Health Impact Assessments & Policy Development in NM

Health Impact Assessments (HIAs) have become more common in the United States as effective ways to demonstrate where and how policies, programs, or plans impact vulnerable communities. Panelists will present and discuss two HIAs conducted in New Mexico. First, Amber Wallin, Kids Count Director at NM Voices for Children, will share findings from a Health Impact Assessment of a food tax in New Mexico. Kitty Richards, Kristine Suozzi, David Wood, and Antoinette Vigil will share their experience conducting a HIA on proposed developments affecting neighborhoods already experiencing high environmental and health burdens. Christina Morris, Health Promotion Specialist, Public Health Division, Northwest Region, will moderate this session.

Expect to share comments and help facilitate an enhanced discussion on how to use effective advocacy in a way to strengthen communities and public health efforts around New Mexico.
